

NTSA Waiver, Release, and Covenant not to Sue

In Consideration of the North Texas Shooters Association (NTSA), a Texas incorporated not-for profit Association, permitting me to engage in their firearms-shooting activities of that Association, I, on my own behalf and on the behalf of my heirs, representatives, administrators and assigns, hereby waive and release any and all claims, demands, causes of action suits and rights I, or anyone acting on my behalf, might have against that Association, its officers and/or its directors and/or its match directors and/or its safety officers for personal injury, including death, loss or damage to my property, which I (or anyone claiming by or through me) may have against that Association and its officers and/or its directors and/or its match directors and/or its safety officers.

Further, I agree that I will not, nor will anyone acting on my behalf claiming by or through me, bring or maintain any suit in Court to assert any claim against that Association, its officers and/or its directors that I might have out of my participation in any activities sponsored, sanctioned, or Approved by that Association, its officers and/or directors.

I understand that engaging in firearms shooting activities involves a very hazardous and dangerous activity with accompanying risks of personal injury or death and loss or damage to personal property, **and I HEREBY VOLUNTARILY ASSUME THOSE RISKS.**

I have read and understand the foregoing provisions of this Waiver, Release, and Covenant Not to Sue and I have executed this instrument voluntarily on this date. I recognize that the Association, its officers and/or its directors and/or its match directors and/or safety officers are not obligated to permit me to participate in any of the Association activities and may terminate my participation in such activities at any time and for any reason.

This instrument shall not preclude the prosecution of any claim that I might have against persons or entities other than the NTSA and/or its officers and/or its directors and/or its match directors and/or its safety officers. In other words, I am releasing, waiving my rights, and agreeing not to sue the NTSA, its officers, and/or directors and/or match directors and/or safety officers at any time for any reason.

This instrument shall remain in full force and effect indefinitely. If any portion of this Waiver is deemed unenforceable, the remainder shall remain in force and effect.

I am Eighteen (18) years of age or older, or I am the parent or legal guardian of the undersigned.

I agree to wear eye protection and a hat with a forward facing brim at all times while on the premises, but not while indoors or when under cover on the rifle range.

I acknowledge that if I break any NTSA Safety Rule which results in an injury, I am personally responsible both criminally and civilly.
